BACKGROUND OF ZAKHENI

Zakheni was registered as Non-profit organisation by the Department of Social Development on 23rd of December2003 after the need was realised that the young population faced challenges which negatively affected their lives, *inter alia* HIV and AIDS, teen pregnancy, substance abuse, gendered violence among others.

To address the challenges, the Centre initiated a project in which the youth are the force responsible in driving and implementing its programs. Peer Education targeting the youth aged (12 – 35 years), became the ideal notion.

The HIV/AIDS Prevention Education project incorporated a Youth Skills development concept, Community Capacity Enhancement (CCE) Methodology; Youth Leadership development sexual and reproductive health rights service.

Zakheni operates in three provinces, Gauteng in Tshwane District, North West in Bojanala district, and Limpopo in Sekhukhune district.

VISION:

Developing healthy, productive young people who will invest back into communities and the environment.

MISSION:

To engage communities by disseminating information that enhances development and mobilize young people to participate in self-growth opportunities.

1. HIV /AIDS Prevention Care & Support


The HIV/AIDS Prevention Care and Support is funded by the National Department of Health (NdoH) in Greater Sekhukhune, Tshwane and Bojanala districts – And Gauteng Department of Health (GdoH) also funds Tshwane district. The Aurum Institute and PEPFAR community grant is supporting Bojanala district.

Among other activities, the programme includes Community Social mobilisation, HIV Testing Services, Treatment Adherence Clubs, Condom distribution, MMC referrals, HIV/TB defaulter tracing and linkages to Care. About 40 Community Care givers are directly attached to facilities in the three districts where the programme is operating.




Performance Reach/Beneficiary



Performance output




Clinic Talks and Condoms Distribution





The HIV/AIDS Prevention programme plays a vital role in the implementation of the 90 90 90 strategies as required by the National Department of Health.

2. ADOLESCENT GIRLS AND YOUNG WOMEN (AGYW: 15 - 24 yrs)

The My Journey AGYW Programme is funded by NACOSA And Global Fund in Tshwane district. Zakheni is the sub-recipient implementing part of Modality one - Biomedical services in Tshwane Region one.

My Journey programmes offers an age-tailored combination prevention services for AGYW aged 15 – 24 years. The modality targets the AGYW out of school in the community ensuring they Test and receive their HIV results, Linking the newly diagnosed AGYW to ART and Reaching a percentage of AGYW out of school with defined layered package with Core Interventions.



3. ADVOCACY MODALITY

The Advocacy Modality programme is implemented in Tshwane District, funded by The Aids Foundation South Africa (AFSA) and Global Fund. Zakheni is a sub-recipient on the in Tshwane Region one.

The Advocacy Modality aims at Influencing public demand for services and create awareness of barriers including human rights violations and gender inequities. Ensures services and programs are responsive to the needs of AGYW in Tshwane District 1, such that they are accessible, acceptable, affordable and of appropriate quality. Create an enabling environment

The focus areas include addressing the negative attitudes toward adolescent sexuality; Uncertainties and inconsistencies arising from Sexual rights Vs. Human rights, HIV testing, Contraception, Treatment – SRHRs services *Inter-alia*; And monitoring access, provision and quality of youth-friendly health services in Facilities or Safe Spaces



The program reached out to 143 AGYW's through Youth Networks and advocacy consultative events. The team recorded verbatim of the participants and created case studies.

Zakheni employs a team of enthusiastic young women and men who are happy to serve the community. Below are from some of the transcripts taken from Lay Counsellors, Peer Mentos and Peer Group Trainers.

"Today I am happy because the program has enabled me to help people to know their status or even take ARV."


"The most important thing I love about my job is that we get to connect with different people."



"My work allows me to learn from the experiences of AGYWs and remain none judgemental. More than anything I'm happy to motivate someone".


